CLINICAL SUPPORT SERVICES TO FOSTER AND KINSHIP FAMILIES CAN ADDRESS THE CRUCIAL NEED FOR EMOTIONAL AND PSYCHOLOGICAL SUPPORT FOR FOSTER PARENTS WHO ARE CARING FOR CHILDREN WITH COMPLEX NEEDS. THIS NEED ARISES FROM THE UNIQUE CHALLENGES AND STRESSORS THAT FOSTER PARENTS OFTEN FACE WHILE PROVIDING A SAFE AND NURTURING ENVIRONMENT FOR CHILDREN WHO HAVE EXPERIENCED TRAUMA, ABUSE, OR NEGLECT.
